This version of the May 2020 Quarterly Meeting minutes contains the edited highlights. The minutes in full detail will be available for consideration at our virtual Quarterly Meeting in August under the care of Newtown Meeting.

Recording Clerk: Betsy Bayardi (Wrightstown)

Friends gathered at 12:50 p.m. and settled into a period of worship.

Welcome given by Wendy Kane.

Agenda: Leo Fitzpatrick made two changes to the agenda. The modified agenda was approved.

**Roll Call of Meeting:** Bristol: 1, Buckingham: 4, Doylestown:5, Fallsington:7, Lehigh Valley: 2, Makefield:0, Middletown:2, Newtown: 9, Plumstead:2, Quakertown:0, Solebury: 3, Southampton: 4, Wrightstown:7, Yardley: 9.

Minutes of February 2020 Quarterly Meeting were approved with the addition of two roll call items - Bristol Meeting 0 and Yardley 5. **Stories of Vitality and Growth:** 

- Newtown MM has been worshipping via Zoom. Worship is vibrant and satisfying and well attended.
- Southampton MM holds Sunday morning worship as well as Tuesday evening.
- Fallsington MM is also worshipping via Zoom and held their first Meeting for Healing.
- Attendance at Bristol has been consistent but low with four Friends regularly at worship.
- Middletown MM is doing well with Zoom. Many members at a distance have participated.
- Doylestown MM has been actively using Zoom for worship. Several Friends joined from a distance.

**Coordinator's Report:** (Complete report available) **Inreach**: Our Quarter Community largely transitioned to virtual worship after the governor issued a stay at home order which commenced the third week in March. Bristol, Plumstead and Quakertown have suspended worship services for the foreseeable future. Our other eleven meetings have at least one virtual service per week. Friends report that virtual worship is meaningful and spirit filled. Wendy has attended several virtual meetings and will continue to make the rounds. **Issues in Progress:** 

- Chandler Hall Worship Services Meetings have been taking one-month turns providing worship services for many years. One meeting left the rotation several years ago because it was difficult to recruit volunteers. Recently another meeting's participants have found the commute too long (30-45 minutes each way). For some, Chandler Hall's worship format is not "Quaker" enough. Currently the majority of worship attendees are not Quaker. The issue will be discerned at the Bucks Quarter Clerks meeting in the near future. Wendy has spoken at length to Kathy Parry who coordinates the Chandler services.
- 2. Wendy is updating the Quarter database using meeting directories.
- 3. Wendy is using Facebook to help Friends stay connected to the wider Quaker world. Wendy is researching Quaker websites and posting what mate of interest to Bucks Quarter Friends.
- 4. Wendy has begun to use Mail Chimp as a more more efficient way to distribute information.

**Outreach:** 1. Wendy served as a greeter and a donor at Yardley's blood drive.

2. Wendy engaged DiGiovine Design to design and launch a website for the Quarter.

3. Quakerism in a Nutshell has been canceled and will be rescheduled once the stay at home order has been lifted.

**Bristol Meeting Annual Report** given by Clerk Paul Shaffer. (See report attached.) Attendance continues to be low but loyal – three or four people each Sunday. Meeting for Worship is held once a month on the fourth Sunday. We repaired three porticos on our building. Historic Bristol Day provides an opportunity to showcase our meetinghouse, our faith principles and our history. We invited an archeologist to do a dig on our property and anticipate doing it again this fall. We have suspended in person worship because of the pandemic and look forward to being able to work together again soon.

**Buckingham Meeting Annual Report** – Reported by Tim Cunningham (See report attached.) Buckingham had a good year. We have 69 adult members and 24 minors, for a total of 93. We mourn the passing of Sandy Langhart, former Bucks Quarter Coordinator. Attendance has been steady. Several new attenders have stayed on. First Day School attendance reaches ten or twelve on many First Days. We now have two FDS groups and rotate teaching duties. BFS, the school under our care continues to grow and thrive. 2020 represents an important milestone for us – the 300th anniversary of our incorporation as a meeting.

**Financial Review and Budget Presentation** – Ed Snyder (Treasurer) reviewed the financial statements for the period July 1, 2019 through March 31, 2020. The numbers reflect the \$26,015 refunded to our monthly meetings, disbursements to PYM, contributions from monthly meetings and operating expenses. Ed Snyder reported that the Quarter is where it should be for nine months into the fiscal year. Ed presented the Quarter budget for the fiscal year 2020-2021. This is a break-even budget which reflects very slightly lower pledges from the monthly meetings. Our contribution to PYM will increase by just under \$7000.

**Annual Report – Chandler Hall/Kendal** (See report attached) Chandler Hall initiated a number of resident centered programs and physical plant improvements to enhance our patients' quality of life. Recognitions and awards included receiving a five star rating (the highest designation available) from Medicare.

**Discussion of the Peace Fair** – Tim Cunningham reported that planning for the fair is underway in full recognition that Bucks County may not be in the green phase by September and the event may have to be cancelled.

Annual Report – Oversight Committee - Lisa Collins described the year as "tough." The committee provided support to our Coordinator through her illness. The committee developed a recruitment process to identify a new coordinator.

Annual Report – Fallsington Meeting (See report attached) David Brimmer described a year of working for social justice and protecting our planet and deepening the meeting's spiritual life. The meeting approved the ministry of Lisa Collins. The meeting also mourned the loss of its long time member and mentor Sam Snipes.

Annual Report – Lehigh Valley Meeting (See report attached) A major focus this year was an exploration of our worship practices, including a multi-generational program titled "Why Do We Gather for Worship?" The meeting was also involved in a number of social justice causes including addiction recovery, food insecurity, immigrant support and mass incarceration and post incarceration re entry. Annual Report – Bucks Quarter Clerk (See report attached): Leo Fitzpatrick expressed thanks to Wendy Kane for her facilitating his orientation into the Clerk role. The Quarter has been active both before and after the pandemic restrictions were imposed. At the

February Quarterly Meeting hosted by Middletown, Vanessa Julye, co-author of *Fit for Freedom, not for Friendship: Quakers, African Americans and the Myth of Racial Justice*, urged our members to take a more active role in eliminating racism. The information packet contained a book titled *Never Caught* – the story of Ona Judge who ran away from George and Martha Washington during their stay in Philadelphia. The Quarter spent the last two Quarterly Meetings trying to develop a response to the Meta Theater Company's concerns regarding inappropriate remarks and actions that followed their February 2019 performance. We received a generous bequest from the Kirkbride estate which will be used to fund outreach activities.

Meeting closed with silent worship at 3:15 pm.
