### Stories of Hope, Support and Light from Around the Quarter

#### From Lehigh Valley Friends:

"Since March 29, we have been holding virtual meetings for worship via Zoom, starting at our regular worship time of 9:30, with 40-45 taking part each week. Our April meeting for business, also conducted via Zoom, had around 30 participants. Because we were unable to enjoy our usual fifth-First Day Frugal Feast of soups, breads, salads at rise of meeting on March 29, the member who coordinates that program suggested that we prepare our own simple meals at home and contribute the proceeds to the Meeting as usual. Funds raised through this 'Faux, Fun, Frugal Feast' were donated to the Pennsylvania Avenue Interfaith Food Pantry, the regular beneficiary, to help them address the growing needs of our neighbors during this challenging time. Although our First Day School has not been meeting, several of the children have also connected via Zoom; on the afternoon of April 12 they took advantage of this opportunity to socialize and begin working on a service project-sending notes to cheer up some of our members who are in isolation."

**Middletown Friends** offered these "Questions for a Time of Quarantine" (from the Peace Center):

- What am I grateful for today?
- What expectations of "normal" am I letting go of today?
- Who am I checking in on or connecting with today?
- How am I getting outside today?
- *How am I moving my body today?*
- What beauty am I either creating, cultivating, or inviting in today?

### From Chiyo Moriuchi, Clerk, Newtown Friends:

"I think the success of Newtown's virtual meetings has been uplifting for all who have participated. We've had well over 50 participants and very gathered worship even as we socially distance. With some slight adjustments in the speaker schedule, we've also continued our Adult Religious Ed classes, also with terrific attendance and participation.

# This version of the February 2020 Quarterly Meeting minutes contains the edited highlights. The minutes in full detail will be available for consideration at our virtual Quarterly Meeting in May under the care of Plumstead Meeting.

**Clerk:** Leo Fitzpatrick (Wrightstown)

Recording Clerk: David Rose (Lehigh Valley)

Friends gathered at the appointed hour of 1:00 pm and settled into a period of worship.

**Welcome** given by Clerk Leo Fitzpatrick. A book, *Never Caught* is included in the packet for Meetings. The book is about the effort of George Washington to reclaim an escaped slave. Leo said that reading the book caused him to revise his view of our first president. **Agenda** reviewed and approved.

**Roll Call of Meetings:** Buckingham: 2, Doylestown: 1, Fallsington: 2, Lehigh Valley: 4, Makefield: 1, Middletown: 5, Newtown: 7, Plumstead: 0, Quakertown: 3, Solebury: 3, Southampton: 2, Wrightstown: 4.

Minutes of November 2019 Quarterly Meeting read and approved.

Stories of Vitality and Growth:

- Newtown MM has a series on Aging Well.
- Lehigh Valley MM First Day students hosted a muffin breakfast as a fundraiser.
- Fallsington MM has initiated a program on "Undoing Racism" for Sunday Adult program. Still working on format and presenter. Details will be provided in Quakerphernialia.
- Yardley MM will be hosting a program on "Truth In Our Time" given by the NYT legal counsel.
- Solebury MM will be supporting Mercer Street Friends with a pancake breakfast with their own maple syrup.
- Quakertown MM will be having two programs on Vocal Ministry given by a sojourning member of NYYM.
- Southampton MM will be accepting two new members at the next Business Meeting.

**Coordinator's Report:** (Complete report available) Wendy Kane presented her report on Intervisitation, Inreach and Outreach activity. Inreach activity included completion of Calendar and Appointment booklet, archiving and purging of Quarter Records, and getting meeting records archived at Friends Historical Library. Outreach included establishing contact with local Quaker institutions, participation in various social actions and PYM gatherings, work on establishing social media presence, and progress on future Quarter programs.

**Friend Home and Village Annual Report** given by Executive Director N. Chiyo Moriuchi (complete report available). She provided an overview of the history of Quaker Boarding Homes and the transition of some of them into the present and spoke of the demographic changes that make FHV more relevant than ever. The current situation for FHV is good with an occupancy rate of over 90%. Invitation extended to come and join in worship, volunteer, donate or recommend candidates for the Board.

**Minute on War with Iran from Lehigh Valley MM** which called for our government to work toward a lasting peace with Iran without resorting to war read by Joyce Hinnefeld (complete minute available). The Clerk encouraged individual meetings to review and consider approving this minute. A number of Friends spoke of the work that is already being done in their meetings regarding the issue. **Break** at 1:55.

Quaker Self Portrait and One Quilt/One Yearly Meeting. Meeting, though small, is contributing to twelve non-profit organizations. Treasurer's Report prefaced with comments by Betsy Bayardi, Clerk of Budget and Nominating, on the work of the Audit Committee which completed its audit and will be submitting their report. Treasurer Ed Snyder presented the "Profit and Loss Budget vs. Actual through December 2019" report and explained the "Balance Sheet as of December 31, 2019" (complete reports available). A Friend asked that the Budget and Nominating Committee look into investing a portion of the assets at Friends Fiduciary in the Friends Fiduciary Green Fund. Request accepted.

**Draft Budget for 2020-2021** presented by Treasurer Ed Snyder. He noted that this is not a balanced budget as the draft showed income in excess of expenses and explained that this is due to some cost reductions.

Approval Requested on the following:

- Due to the period of time that the Quarter was not paying for a Coordinator there is a budget surplus of around \$27,000. Budget and Nominating proposes that the money be refunded to Monthly Meetings based on their proportional contribution.
  Recommendation approved.
- The cost to redesign the BQM Website is expected to cost approximately \$2,500. Budget and Nominating requests that this cost be paid for from Kirkbride Estate Bequest. **Recommendation approved.**

Nomination Report: Betsy Bayardi reported that the Quarter will be recruiting for a new Recording Clerk with the resignation of David Rose as Recording Clerk. The Clerk expressed appreciation for the years of service as Recording Clerk given by David. Doylestown MM Annual Report given by Connie Keener. The activities during the past year included First Day School theme of Social Justice, increasing Peace and Social Concerns awareness, a variety of community building social events, and a digitized newsletter. A Friend commented that an essential part of an annual report should answer the question: "How does the Truth prosper in your area?" which should be an account of attendance at Meeting for Worship and a statement about the quality of worship, which the last two Monthly Meeting reports did not mention.

Annual Report Bucks Quarter Outreach given by Sarah Crofts (complete report available). She summarized the report and strongly requested that meetings ensure that they have a representative to Outreach as it is doing an important job for the Quarter. In response to a question raised by Lehigh Valley MM it was stated that call-in participation would be welcome from meetings at a distance. Much of the work of Outreach during the past year was to be a presence at various events prior to the hiring of Wendy Kane and to work with her as she becomes familiar with the various Outreach activities.

Makefield MM Annual Report given by Jerry Taylor for Boris Simkovich (complete report available).

### Announcements

- Peg Smedly from Yardley MM presented a request from Leonard Education Organization given by Deya' Leonard Dresner.
- Anna Fox, Horsham MM announced Junior Friends Conference for children aged first through 6<sup>th</sup> grade is scheduled at George School June 21 through 27. Pick up a brochure to take back to your Monthly Meeting and encourage young friends to attend. Very reinforcing for your people's Quaker identity.
- David Smith, PYM Nominating Council, has a vast number of positions that need to be filled. Please consider. Need to fill almost all leadership positions in the near future.
- Jerry Taylor from Makefield MM reported that FCNL sent objectives. Peace Fair could use an interfaith council tent.

Meeting closed with a period of silence at 3:15 pm.
